Diplomatic number plates cost:

- For cars: DKK 1,180
- For motorcycles: DKK 590 (Motorcycles can only be registered with white number plates)

If blue number plates are requested, the amount of DKK 1,180 must be paid when submitting the form.

Via online banking (Denmark):

When paying via online banking, use payment type +73 and creditor number + 80774699. In the message field, write 'Diplomatic number plates', your name and the CPR number related to the application.

From abroad:

You can pay via international online banking using the following: IBAN: DK7802164069240186 SWIFT code: DABADKKK

What you need to submit the application for diplomatic number plates:

All applicants:

Proof of ownership, for example a photo of the original registration certificate (used vehicle) or a copy of the document of sale (new vehicle).

If you are applying as an embassy, diplomat or administrative employee:

Declaration 13.004 (franchise) or a signed and stamped letter from the embassy management. As a diplomat or administrative employee, you must also attach a copy of your ID or residence permit.

If you are applying as an employee of an international organisation:

Copy of the Certificate for registration of motor vehicle free of customs, excise duties and VAT, International organisation. Copy of ID or residence permit.

If you are applying as an international organisation:

A signed and stamped letter from the management of the international organisation.

Number plate operator:

If you are a number plate operator, you must attach a power of attorney from the applicant.

The above information is confirmed by the applicant's signature. The information is provided according to section 163 of the Danish Criminal Code (Straffeloven), which reads as follows:

“Any person who otherwise in writing or on another readable medium makes a false statement or representation or confirms the correctness of facts not known to him for use in legal matters involving public authorities is sentenced to a fine or imprisonment for a term not exceeding four months.”
