## Driving vehicle with foreign number plates (loan car)

#### Information

You can obtain permission to drive a foreign-registered loan car for a maximum of 30 days within a 12-month period per Danish-registered vehicle.

The above information is confirmed by the applicant's signature. The information is provided according to section 163 of the Danish Criminal Code (Straffeloven), which reads as follows:

"Any person who otherwise in writing or on another readable medium makes a false statement or representation or confirms the correctness of facts not known to him for use in legal matters involving public authorities is sentenced to a fine or imprisonment for a term not exceeding four months."

# Information

# If the car is a loan car

You must also have your loan agreement in the vehicle so that you can produce it on request.

The loan agreement must contain information that the vehicle is a loan car belonging to a car repair shop, and which has been made available to you while your Danish vehicle is being repaired at a foreign car repair shop. The loan agreement must also state the registration number of your Danish vehicle.

If you fail to return the loan car on the expected date of return, you must fill in the form again, stating a new expected date of return and print a new receipt. Please note that you may drive a loan car in Denmark for a maximum of 30 days within any 12-month period.

The loan car may only be driven in Denmark by persons who:

- are registered in the Register of Motor Vehicles as the owners or users of the vehicle being repaired
- belong to the owner's or user's household
- are employed by the owner's or user's company.

## If you are testing equipment or vehicle

You must also keep the permit for testing issued to the company in the car so that you can produce it if requested to do so.

The vehicle may only be driven for the purpose of fulfilling the commercial purpose specified in the permit granted to the company.
