Documentation When submitting the form to The Danish Motor Vehicle Agency, please remember to enclose supporting documentation and other relevant information. Please note that the commencement and expiry dates must be clearly stated on all the submitted documents.

Please attach following documents:

- Employment contract **or** study contract (depending on the purpose of your stay in Denmark)
- Customs inspection report (the inspection must be less than 4 weeks old)
- Copy of foreign registration certificate
- Certificate of residence (showing that within the past 12 years you have been resident in the Faroe Islands or Greenland for at least 5 years)
- Documentation of VAT and customs payment **or** permission to import a vehicle as removal goods
- Additional documentation (optional).

Supplementary information (optional)

I hereby declare that the information provided is correct and that any change regarding the nature and duration of my stay, the affiliation of the vehicle or its use etc. will be reported immediately to the Motor Vehicle Agency (Motorstyrelsen). I am aware that the rest of the tax falls due for payment when the conditions for a permit are no longer met, unless the number plates are handed back to the Motor Vehicle Agency on the date of expiry of the permit at the latest.

Guidance

This application form should be used by individuals that want to be exempted from paying vehicle registration tax on vehicles imported from the Faroe Islands or Greenland.

On application, permission may be granted for exemption from tax for vehicles that are subject to registration and are imported from the Faroe Islands or Greenland.

The vehicle will be valued by the Danish Motor Vehicle Agency (Motorstyrelsen) for calculation of the vehicle registration tax amount.
